- 6. Public liability insurance cover with a reputable insurer must be in place prior to the activity commencing.
- 7. If traffic control or road signage is to be used, the Notifier must engage qualified Traffic Controllers to assist in the traffic control.
- 8. On completion of the works, the road and surrounding infrastructure must be left undamaged. Should any damage occur to Landholder property or Santos GLNG managed or owned property, it must be notified to Santos GLNG and repaired to our satisfaction cost of the applicant.
- 9. The applicant must contact Santos GLNG and receive approval prior to transport should there be any changes required to operating times and dates or for any other adjustments to the original approval.
